ANOTHER SLOWDOWN IN AUGUST FOR THE ITALIAN AUTOMOTIVE PRODUCTION: -11,9%

Cars production closes the first eight months of the year with -21% and the one related to the automotive industry closes with -9.5%

Turin, October 10th 2019 - According to ANFIA data, **National cars productions** in Italy is keeping to decrease, and in the first eight months of the year it reached 21%.

In September 2019, the Italian car market saw a sales saw a growth of 13%. In the first nine months of 2019 close instead with a negative sign: -2%. During the month, registrations of the FCA Group saw a market share of 22%, with volumes in increase of 11%. In the other sectors, show a positive sign from January to September 2019 only the light commercial vehicles (+7%, and +13% during the month) and light trailers (+3%, with a growth of 10% in September), while are in slowdown trucks (-6%, in decrease of 23% in September), buses (-6%, in despite of the growth of 6% during the month) and heavy trailers e semitrailers (-7%, while during the month the slowdown is of 18%).

In July 2019 (last data available), the value of the vehicles exported from Italy is about 2 billions of Euro, the 4.4% of the total exported, in slowdown of 1.2%. The import vehicles values, instead, 2.5 billions of Euro (+1.3% respect to July 2018), which means the 6.5% of the total exported in Italy. The United States of America still represent, in terms of value, the first country as destination for the export of vehicles from Italy with a share of 16%, followed by France and Germany, both with a share of 14%.

In Italy, the index of the industrial production¹ decreases of 1.8% in August 2019. The average in the first eight months the index registered a trend of slowdown of 0.9%.

"In Italy, the index of the industrial production² registers during August a decrease of 11.9%, with a negative sign which last since the last three months of 2018 - says Gianmarco Giorda, Director of ANFIA. In the first eight months of 2019 the variation of trend is -9.5%.

The Italian production of parts and accessories for vehicles and their engines³ registers once again a negative sign during August and reached 6.3% both during the month and in the cumulate".

During July, according to the last data available, the orders of this specific sector are decreasing of 10.6%, because of the slowdown of the national orders (-12.8%) and of the international ones (-8.4%). In the first seven months of the year, orders register a slowdown of 9,2% (-14.6% and -4% respectively national and international). Also the income of components shows a slowdown of 5.8% during the month, because of the national part which decreases of -11.7%, while the international one back positive (+0.6%). From January to July 2019 the index of the income decreases of 6.9%, with a national part in slowdown of 14.1% (+0.7% the international income).

Orders⁴ in the automotive sector shows a decrease of 10.2% in July ((because of a national part in slowdown of -11,8% and of an international part in slowdown of 8.1%). In the first seven months of 2019 orders decrease of 11.7% (-13.7% in the national market and -9% in the international one). The orders of the industry (with the only exception of the Manufacture sector), present, instead, a slowdown of 1% in July (+0.3% the national part and and -2.9% the international part) and of 2.3% in the first seven months of 2019 (-1.1% the national part and -4.1% the international one).

The income⁵ in the automotive sector, in the end, shows a decrease of 3.1 % in July (-9.9% the national income and +5.7% the international one). During the first seven months of 2019, the income decreases of 8.5% (-12.4% the national income and -3% the international one). For the industry the income (with the only exception of the Manufacture sector), increases of 2.7% instead, during the month (+2.3% on the national market and +3.2% on the international ones) and it closes with +0.1% from January to July 2019 (+0.1% on the national market and +0.3 on the international ones).
