THE TREND OF THE ITALIAN AUTOMOTIVE PRODUCTION IS STILL NEGATIVE (-5.3%)

Car production in slowdown of 16% during the month and of 18% in the cumulate

Turin, July 10th 2019 - According to ANFIA data, during May 2019 the **National** cars productions in Italy is in slowdown of 16% respect to May 2018.

In the first five months of the current year, the car production registered a decrease of 18%.

During June 2019, the Italian car market saw a sales slowdown of 2%. The first six months of 2019 close with a negative: -3.5%. In June, registrations of the FCA Group saw a market share of 23%, with volumes in slowdown of 11%. In the other sectors, see a positive sign in the period from January to June 2019, only light commercial vehicles, (+5.5%, with a growth of 3% in June) and light trailers (+2%, with an increasement of 0.4% during the month), while are in slowdown trucks (-0.2%, in spite of +38% of June), buses (-8%, with a slowdown of 3% in June) and heavy trailers and semitrailers (-7%, while during the month the slowdown of 3%).

During April 2019, the value of the vehicles exported from Italy is about 1.7 bilions of Euro, the 4.3% of the total exported, and it is in slowdown of 10.2%. The import vehicles values, instead, 2.94 bilions of Euro (+2.4% respect to April 2018), which means the 8.3% of the total exported in Italy. The United States of America still represent, in terms of value, the first country as destination for the export of vehicles from Italy with a share of 17%, followed by France and Germany, respectively with a share of 14.7% and of 13%.

In Italy, the index of the industrial production ¹ decreases of 0.7% during May 2019.

"The Italian Production of the Automotive Industry ², registers during May a trend of decrease of 5.3%, which follows the decreases already registered in the first four months of 2019 and in the last three months of 2018 - says Gianmarco Giorda, Director of ANFIA. The closing of the first five months of 2019 registers a trend of decrease of 8.9%.

The Italian production of parts and accessories for vehicles and their engines³ registers once again a negative sign during May, even if it increased respect to April (-0.5%), and also in the cumulate (-6.1%)".

During April, according to the last data available, the orders of this specific sector are decreasing of 3.5%, because of the slowdown of the national orders (-11.9%) and because of the growth of the international orders (+5.1%). In the first four months of the year, orders register a slowdown of 7.7% (-14.8% and -0.9% respectively national and international). Also the income of components shows a slowdown of 7.9% because of the national part which decreases of 13.9% and of the international one which decreases of 1.9% instead. During the period from January to April 2019 the index of the income decreases of 6.2%, with a national part in slowdown of 13.9% (+1.6% the international income).

Orders⁴ in the automotive sector shows a decrease of 8.9% during April (because of a national part in slowdown of 10% and of an international part in slowdown of 7.8%). 9In the first four months of 2019 orders decrease of 10.3% (-12.2% in the national market and -7.8% in the international one). The orders of the industry (with the only exception of the Manufacture sector), present, instead, a slowdown of 0.2% in April (+0.2% the national part and -0.8% the international one) and of 2% in the first four months of 2019 (-1.3 % the national part and -2.9% the international one).

The income⁵ in the automotive sector, in the end, shows a decrease of 7.9% in April (-10.5% the national income and -4.5% the international one). In the first four months of 2019 the income decreases of 11.3% (-15.4% the national income and -5.4% the international one). For the industry the income (with the only exception of the Manufacture sector), grows of 2.5% during the month (+3.4% on the national market and +0.8% on the international ones) and of 0.5% from January to April 2019 (+0.3% on the national market and +0.9% on the international ones).
