IN SEPTEMBER AUTOBUS REGAIN (+5.6%), WHILE TRUCKS STAY STABLE IN DOUBLE FIGURES DECREASE (-22.7%) WITH ALSO TOWED VEHICLES (-17.7%)

To incentivize always more sustainable investments, ANFIA proposes, for the 2020 Budget Law, to extend the super depreciation for the purchase of instruments vehicles, with an increasement more for the purchase of industrial and commercial vehicles with alternative traction

*Turin, October 23<sup>rd</sup> 2019* - In September 2019, have been released **1,198** certificates of **new trucks** (-22.7% respect to September 2019) and **723** certificates of new **heavy trailers** and **semitrailers**, with GVW over 3,500 kg (-17.7%), divided this way: 75 trailers (-41.4%) and 648 semitrailers (-13.7%).

Both sectors confirm the negative trend of the first nine months of 2019: 17,981 certificates of **new trucks**, the 6.4% less than January-September 2018, and 11,219 certificates of new **heavy trailers and semitrailers** (-7.2% respect to January-September 2018), divided this way: 1,077 trailers (-6.6%) and 10,142 semitrailers (-7.2%).

Vehicles market for the transportation of goods, has been affected by the trend of decrease of the industrial production in the first eight months of 2019, -0.9%, which means, a slowdown of the handling of goods. The trend of the industrial production, is affected by the international commercial tensions and by the slowdown of the global level of manufacturing (especially in China and in the Euro zone). To be noted that the highway traffic of the heavy vehicles registers, a positive value anyway, in terms of milion vehicles/km traveled in the first semester of 2019, +2.1%, result of a growth of 2.5% in the first three months of 2019 and of an increase of +1.7% in the second three months, given by the slowdown of May and June. The international traffic slowdown too.

The uncertainty of the entry into force of the Investments Law 2019/2020 affected on the negative trend of both sectors, which designate 25 milions of euro for the purchase of alternative traction, diesel euro 6 commercial and industrial diesel euro 5 vehicles, trailers and semitrailers for intermodality with innovative parts. The measure of this year will edit the use of incentives: it is planned a tender valid until the stock of resource for each plafond, this way will help companies transportation to be sure of the quantum, but it is creating, and it will keep in doing it, in the next months, instability in the market.



Looking at the fueling, gas trucks, register from January to September 2019, a share of 6.2%. More in particular, methane trucks sales grow of 49.5% and the GNL ones of 38.2%. With the goal to incentive always more companies to invest in a sustainable ways, one of ANFIA proposals for the Budget Law 2020, in line with the basics of the circular economy and the decarbonization one, is the extension in time of super depreciation for specious vehicles, with, for example an increasement for the purchase of industrial and commercial vehicles with alternative traction, which are functional goods through the energetic transition for the transportation sector.

In September, buses market with GVW over 3,500 kg registers 475 new units, with an increasement of 5.6%. During the month, grow in double figures minibuses (+41.9%) and scuolabuses (+29.2%), while the other sectors register a slowdown: -6.6% for TPL and -2.1% for tourist and midibuses. In the first nine months of 2019, have been released 3,294 buses registrations against the 3,491 of January-September 2018, with a trend of decrease of 5.6%. Keep a positive sign only schoolbuses (+14.6%), while close in slowdown respect to the first nine months of 2018, TPL buses (-10.4%), tourist buses and midibuses (-4.1%) and minibuses (-4.8%).
