**THE 2019 CAR MARKET OVER 1.9 MILLIONS OF REGISTRATIONS (+0.3%),
THANKS TO A DOUBLE FIGURE INCREASE IN DECEMBER (+12.5%)**

In 2020, with the objectives for the CO₂ emissions reduction for the new registered cars, manufacturers should also point at the renewal of fleet aim to an emission profile appropriate according to the law

Turin, January 2nd - According to the data published today by the Minister of Infrastructures and Transport, during December the Italian car market totalized 140,075 registrations, in increase of 12.5% respect to the same month of 2018.

During 2019, the volumes registered reached, 1,916,320 units, the 0.3% more respect to the volumes of 2018.

"During December 2019, the Italian car market show a double figure growth - and it was not happening since last September - thanks also to a working day more respect to December 2018 (20 days against 19) - says Paolo Scudieri, President of ANFIA. Registrations during the month, going over 140,000 units, are over the average of the last 4 years, from 2015 to 2018, in December (120,000 units in average). The recover of sales registered starting from September 2019 - influenced by a phase in 2018 with super low volumes because of the entered into force of WLTP - which has been crucial for the positive closing of the second semester of the year (+5.5%), followed by a negative first semester (-3.4%), only April registered a growth (+1.8%).

The year just ended, opened with the concern for the Bonus-Malus law entered into force last March 1st, influenced the first months of 2019 containing the order of rechargeable cars (BEV+PHEV) before the measure, and strongly increasing during April, with 1,736 new registrations, with means the 80% of what has been sold from January to March 2019. The growth of sales of rechargeable cars in 2019 (+68% from January to November) has been lower than one registered in 2018, without the ecobonus, with double figure volumes respect to 2017.

In 2020, with the objectives for the CO₂ emissions reduction for the new registered cars, manufacturers should also point at the renewal of fleet aim to an emission profile appropriate according to the law. For the current year the available resources of the ecobonus reach 70 million of euro, plus 15,5 million left over in 2019. ANFIA, asked a structural increasement of the ceiling, since the high availability of modes, included the ones produced by FCA, that - with an offer that consist in smart solutions for recharging both public and private - could attract an higher number of buyers of rechargeable cars.



2019 will be reminded as the year in which diesel lost its market leadership in favor of petrol, with a penetration share of 40% in the 12 months, against the 51.2% of 2018.

The year has been marked by the agreement between FCA and PSA, that the Italian production chain welcomes positively and now it opens the implementation phase. The beginning of the decade just ended has been characterized by the fusion between Fiat Group Automobiles and Chrysler, giving the way to a period of great transformations which changed the balances of the world at the global level, in terms of markets and players, with aggregations of actors and knowledges.

2020, that opens a decade even more challenging for the evolution of this sector, debut in the contest of an heavy productive slowdown: the index of production of the Italian automotive industry, in decrease in the last three months of 2018, loses the 9.9% during January-October 2019, with orders in slowdown of 11.1% (-14% the national part) from January to September 2019. In December, both the company and the consumer confidence climate are growing. To the car industry is required to deal with an historic productive reconversion that imply big investments: this is a process which need a system approach and a shared vision among all the actors involved, to guarantee a return for the investments.

Yesterday, entered into force, a new tax for business cars in fringe benefit included in the Budget Law 2020 and applied for cars registered from January 1st for contracts signed from July 1st 2020. The currently formulation of the measure (with the preferential taxation for BEV and PHEV with CO₂ emissions until 60 gr/km), agreed with MEF after a strong activity, give an environmental value to the benefit taking into account the timing of the introduction in the market of ECV produced in Italy.

Always talking about the tax system, in the end, as already happened in 2019, also in 2020, fortunately, have not been spring into action the usual tariff adjustments for road tolls of the beginning of the year, on the 95% of Italian highways, delayed by the Milleproroghe law".

As usual, ANFIA will release in the next days the in-depth analysis about the structure of the Italian market in December and in the whole 2019, included the detailed study.

According to ISTAT data, in December the consumer confidence climate index, (basis 2010=100), registered a growth which pass from 108.6 to 110.8. Also, the composite index of the company confidence climate (lesi) show an increase, passing from 99.2 to 100.7.

Referring to the consumer confidence climate regarding the purchase of the long-lasting goods and among them there is the car, the balance regarding the current opportunity is growing respect to November (from -52.2 to -51.6).

According to the last ISTAT data available, in November the **national index of consumer prices** register a slowdown of 0.2% per month and an increase of 0.2% per year (like in October). The stability of the inflation characterize all sectors: the slowdown of the prices of the services related to Transportations (from +1.8% to +1.3%) is balanced by the lower dimension of the slowdown of prices of long-lasting goods and by the acceleration of semi long-lasting goods.

The energetic goods not regulated keep in registering a slowdown of 3% (from -3.1% in October): the large slowdown of Diesel prices from -3.9% to -4.7% in terms of trend (-0.6% per month), while Petrol ones decrease less from -4.0% to -3.2% (-0.6% the situation).

National brands, overall, totalized during the month 31,308 registrations (-2.3%), with a market share of 22.3%. In the whole 2019, the registrations in the overall reach the 458,745 units (-9.1%), with a market share of 24%.

FCA brands (excluding Ferrari and Maserati) totalized in the overall 30,973 registrations (-2.3%), with a market share of 22.1%. Positive trend for FIAT brand (+2.9%) and Alfa Romeo (+4.8%). Good also Maserati (+9.9%).

In the twelve months, FCA brands totalized 452,025 registered cars, with a slowdown of 9.5% and a market share of 23.6%. Closed positively the period from January to December Lancia brand (+21%), together with Ferrari (+24.1%) and Lamborghini (+47.6%).

Five Italian models are included in the **top ten of December**, with Fiat Panda (10,221 units) always at the first place, followed by at the third place by Lancia Ypsilon (3,922) and at the sixth Jeep Compass (2,844). At the seventh place there is Fiat 500X (2,746) and at the eighth there is Renegade (2,701).

The **second-hand market** totalized 320,799 ownerships transfers, including the mini-transfer operations to car dealers in December 2019, registering a slowdown 4.9% respect to December 2018. In the whole 2019, the ownerships transfers are 4,185,530 the 5.4% less respect of 2018.
